## MEET YOUR MATCH 5 GRINSPOON INSTITUTE FOR JEWISH PHILANTHROPY



#### **Guidelines**

- Eligibility for *Meet Your Match 5* is open only to those camps that have been approved for participation in the Grinspoon Institute for Jewish Philanthropy and have an assigned mentor (See list below).
- For a gift to be eligible for matching funds, a **new donor** must make a minimum gift of at least \$10,000 in a single pledge to a camp. A **new donor** is an individual, family, corporation, or foundation that has not made a pledge or gift of \$10,000 or more since December 31, 2008.
- For a gift to be eligible for matching funds, a **previous donor** of \$10,000 or more (made after December 31, 2008) must triple the size of the previous gift. A **previous donor** may be an individual, family, corporation, or foundation.
- Members of the same family may give a "combined" single gift of \$10,000 or more. "Family" is limited to spouse, parents, grandparents, siblings, and children. Family trusts, foundations, and corporations may also qualify as donors. Gifts from a Jewish Federation or the Foundation for Jewish Camp are not eligible.
- Donor gifts and matching funds must be used for **capital improvements**, defined as the following:
  - 1. Construction of buildings or portions of buildings
  - 2. Major repairs to buildings or portions of buildings, but not maintenance
  - 3. Improvements to grounds, but not normal upkeep
  - 4. Major pieces of equipment
  - 5. Infrastructure construction or maintenance of septic and water systems
- Camp must submit a MYM 5 Application for every pledge to be included in the campaign, by the pledge deadline of December 31, 2012.
- The first payment of at least one-third of the pledge amount must be made within 60 days of the Application date, or the reserved funds will be released.
- Matching funds will be distributed on a quarterly basis (starting April 2012) based on the paid portion of pledge (must include copy of check or credit card receipt).
- All pledges must be paid in entirety by **December 31, 2014**.
- All decisions for matching funds are at the sole discretion of the Harold Grinspoon Foundation. Terms and conditions are subject to change and/or termination at any time.

## **Instructions for Application**

- 1. Provide the camp name and contact information (Section 1).
- 2. Please check the box (Section 2) to indicate permission for Harold Grinspoon to send a personalized acknowledgment to the donor. In the donor information section (Section 3), include how the acknowledgment should be addressed and contact information.

Examples:

Names for envelope address: Salutation: Mr. and Mrs. Samuel Cohen Dear Mr. and Mrs. Cohen, Dr. Samuel and Janice Cohen Dear Samuel and Janice. Samuel and Janice Cohen Dear Sam and Janice.

- 3. Provide the total pledge amount and anticipated date of first payment (Section 4). Note that first payment of at least one-third of the pledge amount must be made within 60 days of the Meet Your Match 5 Application date.
- 4. Indicate pledge designation (specific capital needs to be addressed) (Section 5). Refer to the guidelines for capital improvement use of this pledge.
- 5. Provide information on previous gifts made by current donor to the camp, including date and amount of last pledge (not payment) (Section 6).
- 6. Have Application signed and dated by the Camp Director (Section 7).
- 7. Attach a copy of the pledge card or letter (written terms of pledge) signed by the donor.
